SUMMER 2025 In 2025, New York's eating and drinking places are projected to contribute **\$93.3B in direct economic output** to the state's economy, support **801,686 jobs**, and deliver **\$34.19B in total labor income**, including wages, salaries, and proprietors' income, and benefits.

These contributions spur additional spending in the U.S. economy. When including indirect and induced impacts from employees, suppliers, and others in the surrounding area, the industry's total economic impact rises to \$155.42B in output, supporting 1,041,298 jobs, and \$56.82B in total labor income.

The industry will also be a major source of public revenue. Direct contributions will total **\$19.2B in taxes** to all levels of government, including \$1.15B in county taxes, \$4.08B in state taxes and \$8.11B in federal taxes. With induced and indirect effects included, total contributions will reach **\$29.32B in taxes**, with \$1.52B in county taxes, \$6.18B in state taxes and \$13.64B in federal taxes.







