SUMMER 2025 In 2025, South Dakota's eating and drinking places are projected to contribute **\$3.93B** in direct economic output to the state's economy, support **42,047** jobs, and deliver **\$1.15B** in total labor income, including wages, salaries, and proprietors' income, and benefits.

These contributions spur additional spending in the U.S. economy. When including indirect and induced impacts from employees, suppliers, and others in the surrounding area, the industry's total economic impact rises to **\$6.34B in output**, supporting **53,133 jobs**, and **\$1.89B in total labor income**.

The industry will also be a major source of public revenue. Direct contributions will total **\$532.93M in taxes** to all levels of government, including \$22.85M in county taxes, \$143.10M in state taxes and \$261.80M in federal taxes. With induced and indirect effects included, total contributions will reach **\$787.82M in taxes**, with \$30.12M in county taxes, \$190.28M in state taxes and \$429.2M in federal taxes.







